The National Stock Horse Association is proud to announce the inaugural **NSHA Stock Horse Sires Incentive**. New for 2024, the NSHA Stock Horse Sires Incentive is designed to showcase stallion's offspring by competing in a cow work challenge which will run concurrently with the NSHA Futurity and Derby.

All registered horses aged 3-5 years, sired by a NSHA Stock Horse Sires nominated stallion, will be eligible to compete for the NSHA Stock Horse Sires purse. This class will run concurrently with the NSHA Futurity and Derby held at South Point Arena August 20-25, 2024.

The horse **MUST** be entered in the Open Futurity or Open Derby to be eligible to run for the NSHA Stock Horse Sires purse **AND** must receive a score for herd and rein work. A zero is a score. Scratches or disqualifications makes entrant ineligible. Placing in the cow work portion of the Open Futurity/ Open Derby will determine the placing for the NSHA Stock Horse Sires money. Monies will be split according to entries between the Futurity/Derby.

For 2024 an entry fee of \$350 is due into the NSHA Stock Horse Sires Incentive along with the 3-year-old nomination fee of \$250 **AND** the stallion nomination to complete the entry.

Beginning in 2025 all stallions will need to be nominated yearly and all foals will need to be nominated yearly to be eligible to compete.

## **2025 SIRE NOMINATION RULES**

<b>Offspring Cow Horse Earnings</b>	<b>2025 Rate</b>
Less Than \$100,000	\$3,000 due Mar 1
Less Than \$ 1 Million	\$5,000 due Mar 1
Over \$1 Million	\$ 5,000 + Stallion Fee due Mar 1

**20% Late Fee after March 1**

**50% Late Fee after July 1**

## **PAYOUT**

***The nominator of the stallion will receive 25% of the monies won.***

***The owner of the competing horse will receive 75%.***

The Nomination Rules are as follows:

### **NOMINATION RULES**

- Any horse sired by one of the NSHA Stock Horse Sire stallions is eligible.
- Only ONE nomination payment is due per horse per Calendar year to enter and compete.
- Nominations are non-transferrable (you may not transfer them to another horse) and non-refundable.

Weanling Nomination	\$250 by December 31st
Yearling Nomination	\$250 by Mar 1 <sup>st</sup> , \$300 after
2-Yr Old Nomination	\$250 by Mar 1 <sup>st</sup> , \$300 after
3-Yr Old Nomination	\$250 by Mar 1 <sup>st</sup> , \$300 after

**\*\*The stallions first year of nomination all offspring pay \$250 to bring nomination status current. Then it will resume to a yearly schedule. \*\***
